
An appeal has been submitted to The Planning Inspectorate despite a record number of objections and having been unanimously refused by Hertsmere Planning Committee. The developer's objective will permanently destroy 320 acres of Green Belt Land and install over 100,000 3m/10d high solar panels - over 210 football pitches.
