Since we have not achieved the level of community support we had hoped for, we cannot proceed to challenge the inspector's decision.

Taylor Wimpey will always have superior resources at their disposal. A small environmental group such as Woodcock Hill Village Green Committee can never hope to match that. The replacement land at Barnet Lane will be completely different from the exchange land. The land at Barnet Lane will be a managed rural park. The exchange land is a Nature



Reserve managed by volunteers from the community with ponds to improve habitats and biodiversity.

Taylor Wimpey has stated it will fence the land until it gets permission to build.

What we have decided to try and do is to register some or all of the footpaths on the Village Green, especially those crossing the release land, as a public

right of way by means of a Definitive Map Modification Order (DMMO). To do this we need as many users of those paths for over 20 years to fill out the form overleaf. Please alert anyone you know who can also contribute to this. More forms are available on request.
